Your Continuing Education credit will be reported to the NMLS. You must register and receive a Unique Identifier Number prior to taking the course(s) in order to receive NMLS credit. Once you register, the NMLS will provide you with a User ID. The User ID is your Unique Identifier Number.

For annual continuing education, the SAFE Act requires state-licensed MLOs to complete:

- a. 3 hours of Federal law and regulations;
- b. 2 hours of ethics that shall include instruction on fraud, consumer protection, and fair lending issues;
- c. 2 hours of training related to lending standards for the nontraditional mortgage product market; and
- d. 1 hour of undefined instruction on mortgage origination.

The SAFE Act specifically prohibits the taking of the same course for CE credit in successive years. For example: If you take RESPA in 2011 and report it for CE Credit, you cannot take RESPA and use it for CE credit in 2012. If you take FHA, USDA and VA and all are reported, you may not take FHA, USDA and VA in 2012 for CE credit. Courses that are taken but not reported for 2011 CE Credit may be taken again in 2012 for CE Credit. To verify your reported CE Credit, you must log-in to your NMLS Portal. **FAMP cannot verify information in your NMLS portal. You must indicate which Federal Law Course and/or Non-Traditional Course you would like FAMP to report to NMLS for credit.**

POLICIES: Photo ID required at check-in. Materials are only available to attendees who pre-register to attend the seminar. Registration deadlines and cancellations are established as 7 days prior to each event. You will not receive a refund for any session cancelled after the deadline.
