**Meet face to face with Bill Matthews, the President and CEO of State Regulatory Registry, LLC (SRR). NMLS is the official and sole system for companies and individuals seeking to apply for, amend, renew and surrender licenses managed in the NMLS on behalf of the jurisdiction's governmental agencies.**

Under the S.A.F.E. Act, all states must implement a mortgage loan originator licensing process that meets certain minimum standards and must license loan originators through NMLS. NMLS is the web-based system that will allow licensed mortgage originators to complete a single uniform form electronically, regardless of the number of states in which they are licensed.
